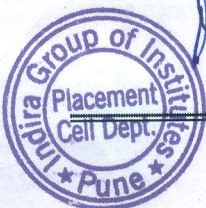

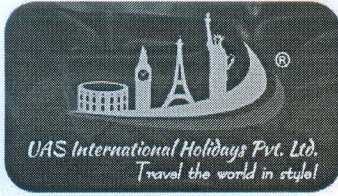

3.1 UAS International will be completely responsible for handling the Immersion Program and all communications with the host international university. "Indira Group of Institutes" will have no liability in this.

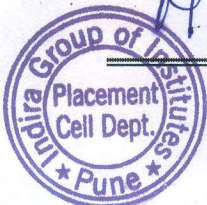
3.2 UAS International will be completely responsible for all concerns or issues that the students may have during the program. "Indira Group of Institutes" will have no liability in this.

5. Will be coming for campus recruitment where intake depends up on the clearance of all the rounds by the candidate in the selection process

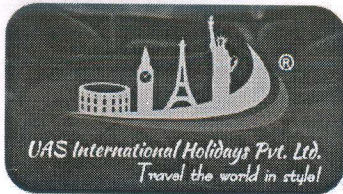

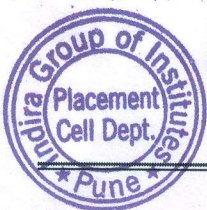

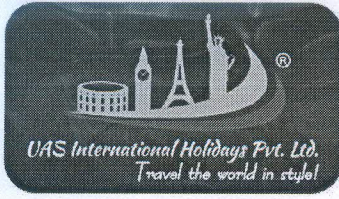
